REGULATIONS

on the Student Environmental Club of the University of World Economy and Diplomacy – "UWED Eco Club"

I. General Provisions

- 1.1. These Regulations define the goals, objectives, rights, responsibilities, and procedures for organizing and financing the activities of the Student Environmental Club (here referred to as "UWED Eco Club") at the University of World Economy and Diplomacy (here referred to as the "University").
- 1.2. "UWED Eco Club" operates in accordance with the Constitution of the Republic of Uzbekistan, the Law of the Republic of Uzbekistan "On Education" and the Law of the Republic of Uzbekistan "On Environmental Protection," the University Charter, and these Regulations.
- 1.3. Academic mentoring and support for the activities of "UWED Eco Club" are provided by a professor appointed by the Dean of the Faculty of International Economics and Management of the University.

II. Goals and Objectives of the Club

- 2.1. The main goals of the "UWED Eco Club" are:
- forming environmental culture, increasing students' environmental literacy, and providing the university community with knowledge and tools for implementing sustainable ideas and activities for environmental preservation;
- supporting the implementation of governmental policies in the field of environmental protection and rational use of natural resources;
 - developing students' research skills in the field of ecology;
- engaging the university community in practical environmental protection activities;
- fostering a sense of responsibility for maintaining a green environment,
 motivating interest, and respect for environmental protection;
- providing opportunities for active participation in solving environmental problems and involving students in environmental decisionmaking processes;
- creating opportunities for the university community to directly engage with environmental challenges.
- 2.2. To achieve these goals, the "UWED Eco Club" carries out the following tasks:

- organizes events to raise environmental awareness among students and the public;
 - conducts scientific research in the field of ecology;
 - participates in environmental projects and programs;
- cooperates with university faculties, non-governmental non-profit organizations, civil society institutions, and other public associations in implementing environmental projects;
- provides environmental education and awareness programs for students and the public;
 - engages students in research, project, and social activities;
 - promotes a healthy lifestyle and environmentally responsible behavior;
 - shares experience and provides mentorship within the Club;
 - facilitates professional orientation in the field of ecology.

III. Rights and Responsibilities of the Club

- 3.1 «UWED Eco Club» has the right to:
- involve specialists from the University and other organizations in its activities;
- organize and conduct events aimed at achieving the Club's goals and objectives.
 - 3.2. «UWED Eco Club» is obliged to:
 - conduct its activities in accordance with these Regulations;
- submit reports on events and annual activity reports to the University administration.

IV. Organization of Club Activities

4.1. Membership in "UWED Eco Club" is voluntary.

Students, faculty, and university staff who share the Club's goals and objectives and actively participate in its activities can become members.

4.2. The General Assembly of the members of "UWED Eco Club" is the highest governing body of the Club.

The General Assembly of the Club:

- determines the main directions of the Club's activities;
- elects the Club Chairperson, Deputy Chairperson, Secretary, and group coordinators;

- approves the structure, responsibilities of the leadership, reports, and other internal Club documents.
 - the Club is managed by the Chairperson.
 - 4.3. The Chairperson of "UWED Eco Club":
 - organizes and leads the Club's activities;
- represents the Club in relations with university faculties, non-governmental non-profit organizations, civil society institutions, and other public associations within the framework of environmental projects;
 - approves the Club's work plans;
 - is responsible for the results of the Club's activities;
 - handles other matters related to the Club's activities.
- meetings of the General Assembly of Club members are held as needed but at least twice a year.

V. Financing of Activities

5.1. The activities of "UWED Eco Club" are financed by the university's off-budget funds, sponsorship donations, and other sources that do not contradict the legislation of the Republic of Uzbekistan.

VI. Final Provisions

- 6.1. These Regulations come into force upon approval by the Academic Council of the University.
- 6.2. Amendments and additions to these Regulations are made by decision of the Academic Council of the University.
