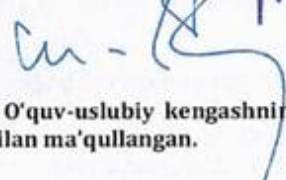

1. Course Description

The course *Political Sociology* examines politics as a sphere of social life, focusing on its socio-economic foundations, the socio-political stratification of social

systems, and the structure and levels of political consciousness. It also explores the interaction between politics and society, as well as the interrelationship between social relations (the social sphere) and political institutions.

The course enables students to analyze the mutual influence of social and political processes within various societal contexts.

2. Prerequisites

No prerequisites are required for this course.

3. Course Objectives

Students will study the concept of power and its dominance within social relations, as well as political processes and phenomena in different social environments. The course also examines the interaction between political phenomena and social structures across different historical space-time continuums, including the context of Uzbekistan.

Upon completion of this course, students will be able to conduct comprehensive research in the political sphere using sociological methods.

4. Learning Outcomes

Upon successful completion of this course, students will be able to:

1. Understand the key concepts, categories, and theories of political sociology;
2. Develop skills in researching socio-political processes within society;
3. Apply the principal research methods of political sociology;
4. Conduct political forecasting of social processes;
5. Acquire systematic knowledge of the emergence and development of political sociology as a component of the social sciences and humanities;
6. Formulate and implement conceptual frameworks for political research projects;
7. Critically evaluate academic literature and generate sources relevant to sociological research in politics;
8. Identify and justify the key components of the research base related to specific research problems;
9. Explain and justify methods of data collection used in sociological research.

5. Independent Study and Assignments

I. Independent Study

Independent study is aimed at deepening students' knowledge of the course and involves the individual study of core and supplementary literature required for writing essays based on selected academic sources.

The main requirements for this form of independent work are as follows:

1. Writing an essay based on the assigned literature;
2. Assessment criteria include independence, creativity (analytical approach, development of ideas, originality in problem formulation, and focus on problem-solving), and the validity of arguments;
3. Style and presentation (overall literacy, clarity, and readability of the text);
4. Essay requirements: length – 800 words ($\pm 10\%$); font – Times New Roman; line spacing – 1.5; font size – 14;
5. Logical coherence and consistency of presentation.

II. Independent Assignments

Students are required to complete four independent assignments in the form of individual tasks within the specified deadlines. These include identifying the foundations of political research problems, selecting appropriate methodology, methods, and research techniques based on applied studies, conducting field research, and preparing analytical materials in formats such as video or poster presentations.

In this context, the course covers the main types of traditional and modern mass media, classical and emerging genres of journalism, convergent journalism, and the growing role of social networks as an integral part of the media sphere, including the legal frameworks governing their operation.

Given that mass media can exert both intentional and spontaneous influence on public opinion, particular emphasis is placed on preparing specialists in the fields of public policy and diplomacy.

2. Prerequisites

No prerequisites are required for this course.

3. Course Objectives

Students will develop knowledge of modern mass media and acquire practical skills for effective interaction with media professionals. They will gain competencies in organizing press conferences and briefings.

Additionally, students will learn how to properly prepare and conduct interviews, participate in talk shows, write and disseminate press releases, and organize presentations and press tours.

4. Learning Outcomes

Upon successful completion of this course, students will be able to:

1. Understand the fundamentals of the history and theory of journalism, as well as recognize that mass media integrates methodologies, methods, and conceptual frameworks from related disciplines such as political science, philosophy, sociology, psychology, logic, linguistics, literary studies, and information technology;
2. Demonstrate knowledge of the main types of traditional and modern mass media, classical and emerging genres of journalism, convergent journalism, and the role of social media as part of the media ecosystem;
3. Understand the legal foundations of mass media activity, as well as the rights and responsibilities of journalists, and apply this knowledge in practice;

4. Analyze and interpret ethical and legal issues related to mass media and social media actors;
5. Understand global processes of transformation and development in international mass media, classify media actors worldwide, and assess their capacities for information dissemination, as well as the role of media and media education at the global level;
6. Demonstrate skills in effective cooperation with media professionals and in organizing information dissemination aimed at shaping a positive image of the country abroad;

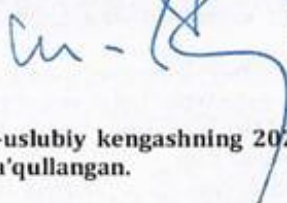

The course *Political Parties and the Electoral Process* is designed to demonstrate the interrelationship between theories of party-building and empirical fields such as sociology and political science. Within the framework of the discipline, issues of political behavior as a form of participation in the exercise of power are examined, particularly focusing on the factors and motivations underlying electoral behavior shaped by the activities of political parties.

The course is aligned with the general curriculum of the *Political Science* program at UWED and is structured with consideration of the knowledge students acquire from related courses.

It provides a systematic overview of the history of political and social doctrines, as well as the sociobiological and cultural foundations of political parties, their emergence, and forms of political mobility. Within the study of electoral systems, the structure of power and political leadership is analyzed. Upon completion of the course, students will also gain practical skills in conducting campaign research.

2. Prerequisites

No prerequisites are required for this course.

3. Course Objectives

The primary objective of this course is to provide students with foundational political knowledge, develop their competencies in political science, and ensure a deep understanding of the categorical apparatus of the discipline and its practical application.

Additionally, the course aims to enhance students' ability to critically evaluate events and phenomena occurring in contemporary international political processes.

4. Learning Outcomes

Upon successful completion of this course, students will be able to:

1. Understand key concepts and categories of political science related to political parties, including those in Uzbekistan;
2. Develop skills in analyzing political processes within society, particularly those related to different forms of political expression and will formation;
3. Apply the principal methods of political technologies;
4. Conduct political forecasting related to social processes;
5. Acquire systematic knowledge of modern methods for assessing and analyzing public opinion;

6. Design and present conceptual frameworks for their own electoral campaign projects;
7. Understand the phenomenon of political parties, including their origins, causes of emergence, and current development;
8. Identify and substantiate the key components of a research base in the field of electoral competition;
9. Analyze the political landscape of Uzbekistan through the prism of its political parties.

1. Course Description

The **Military-Political Diplomacy** course is focused on studying the essence, principles, and instruments of diplomatic activity in military and political spheres. Within this course, students examine the theoretical foundations of military-political diplomacy, its historical development stages, and contemporary directions. Special attention is given to its role in ensuring national and international security. The course also analyzes international experience, the activities of international organizations, and the specificity of foreign policy interests, with a focus on their implementation through military diplomacy.

2. Prerequisites

This course does not require any prerequisites.

3. Course Objectives

The objectives of the course are to:

- Develop a systematic understanding of military-political diplomacy as a key area of international relations;
- Study the theoretical and methodological foundations and main concepts of military diplomacy within the context of global and regional security;
- Examine the historical stages of military-political diplomacy and their influence on contemporary practice;
- Develop skills to analyze international agreements, treaties, and diplomatic practices in the military sphere;
- Understand the role of international organizations and institutions in regulating military-political processes;
- Recognize and assess modern challenges and threats related to military diplomacy;
- Develop practical skills in negotiation and communication within the military-political domain;
- Cultivate analytical thinking for professional application of acquired knowledge in foreign policy activities.

4. Learning Outcomes

Upon successful completion of the course, students will demonstrate the following knowledge, competencies, and skills:

Knowledge:

- The essence, functions, and principles of military-political diplomacy;

- Historical stages of military diplomacy and their impact on contemporary international practice;
- Normative and legal frameworks governing international cooperation in the military domain;
- The role of international organizations (UN, OSCE, NATO, SCO, etc.) in regulating military-political conflicts and strengthening security.

Competencies:

- Ability to analyze military-political processes and identify factors influencing state foreign policy;
- Ability to evaluate the effectiveness of diplomatic tools in international crises and conflicts;
- Readiness to apply knowledge in forecasting trends in military-political developments;
- Ability to compare national and international experiences in regulating military and political issues.

Skills:

- Competence in working with analytical materials, international treaties, and diplomatic documents;
- Ability to formulate conclusions and recommendations based on military-political analysis;
- Communication skills for participating in negotiations and dialogue on military security issues;
- Knowledge of key methods for analyzing and assessing risks associated with international military activity.

Overall, the course provides students with a comprehensive understanding of military-political diplomacy, develops their analytical and practical abilities, and prepares them for future professional activities in international relations and national security.

5. Independent Study and Assignments

I. Independent Study

Independent work aims to deepen students' knowledge of the course through individual study of core and supplementary literature, as well as materials from international organizations and analytical centers. This includes preparation for seminars, presentations, essay writing, and completion of assigned tasks.

Independent work includes:

- Preparation on seminar questions, summarizing and analyzing recommended sources;
- Presentations on issues in military-political diplomacy;

- Writing essays and term papers based on academic literature and international documents, with special attention to topics related to international and regional security.

Requirements for this independent work format:

- Writing essays based on the assigned literature;
- Demonstrating independence, critical and logical thinking, analytical approach, and originality in problem formulation;
- Proper structure, sequence, grammar, and cohesion of the text;
- Essay specifications: 1200 words ($\pm 10\%$), Times New Roman, font size 14, line spacing 1.5.

II. Semester Assignments

Students complete five independent tasks during the semester, including presentations, essays, and term papers, which are presented and discussed in class.

III. Instructor Support

The instructor provides guidance in an academic mentorship format, taking into account students' preparation levels and research interests, and supporting individual approaches.
