## **1. COURSE DESCRIPTION**

The course examines the concept and nature of legal research, its goals and objectives, as well as the relationship between law and other social sciences. Particular attention is paid to selecting a research topic, formulating a research problem and hypothesis, and setting goals and objectives.

Modern methods of legal analysis are studied—dogmatic, comparative-legal, historical-legal, sociological-legal, and interdisciplinary.

The course also introduces methods for searching for and processing legal information, working with doctrinal sources, case law, and normative acts. Issues of academic ethics, citation rules, and plagiarism prevention are discussed. The practical component includes the development of research projects, writing essays, term papers, and final qualifying theses.

## **3. COURSE OBJECTIVES**

This course is designed to equip students and young researchers with the fundamental knowledge and practical skills necessary for conducting legal research. It covers key approaches, methods, and tools for analyzing legal phenomena, as well as the principles of developing and formatting academic papers.

**4. LEARNING OUTCOMES**

Upon completing the course, students will be able to critically analyze legal phenomena, formulate research questions effectively, and present their findings in a well-reasoned manner. The course serves as a foundation for further academic work and in-depth study of law.

**5. INDEPENDENT STUDY AND INDEPENDENT WORK**

- I. Independent study is conducted to deepen students' knowledge of the subject and involves individual study of the primary and supplementary literature required for writing independent papers based on previously selected specialized literature.
  - II. The main requirements for this form of independent study are: (1) completion of assignments based on the literature provided for independent study; (2) the following are taken into account when evaluating the work: independence, creativity (analytical approach, generation of ideas, novelty of the problem formulation, attention to problem-solving), and the validity of the proposed rules; (3) style (general literacy, ease of understanding the text); (4) consistency and logical presentation.
  - III. Students complete independent work in the form of assignments no later than the specified deadline (individual work on a case study [of the student's choice]).
- Students must submit all assignments on time. Missed assignments will not be resubmitted.

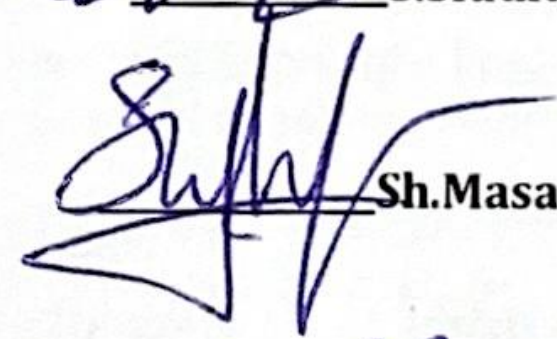

## **Course Description**

This course covers the nature of transactions widely used in international commercial transactions and the issues of their contractual legal regulation. Students will acquire the theoretical and practical skills to draft various contracts used in international commercial relations. This will assist them in writing their chosen dissertation and academic papers on the topic of international commercial contracts. It also provides guidance on identifying problems for a research paper and developing proposals for their solution.

## **Course Prerequisites**

No prerequisites are required for this course.

## **Course Aims**

The aim of the course is to equip postgraduate students with the skills to understand the nature of international commercial contracts, their contractual legal regulation, and their practical application.

## **Learning Outcomes**

Upon successful completion of this module, students will have acquired the following skills:

1. An understanding of the legal nature and types of international commercial contracts and their regulation under international law;
2. develop practical skills in analysing, drafting, performing and terminating the terms of international commercial contracts;
3. understand the rights, obligations and liabilities of the parties in various contracts;
4. conduct analysis and expert review of international commercial contracts;
5. distinguish between types of international commercial contracts;
6. acquire knowledge of the legal regulation of international commercial contracts;
7. to develop legislative proposals on topics relating to international commercial contracts and to conduct comparative analysis.

## **Independent Study and Independent Work**

I. Independent work for master's students of this subject carried out with the aim of deepening students' knowledge of the subject, and involves the independent study of primary and supplementary literature required to write and present a project on a pre-selected topic.

The main requirements for this form of independent work for master's students are as follows: (1) to write a project on the topic selected for independent study (in accordance with the specified requirements); (2) In assessing the work, the following are taken into account: independence, a comparative analytical approach, and substantiated recommendations; (3) stylistics (overall literacy, clarity of text)

II. The master's student must submit the project work by the specified deadline. Late submission of the project work is not permitted.

## 1. COURSE DESCRIPTION

The course introduces students to negotiation and mediation as complementary and widely-used methods of private dispute resolution. It covers core negotiation theory and practice—including distributive and integrative bargaining, interests versus positions, bargaining tactics, deal design, and multi-party and cross-cultural negotiation dynamics. The mediation component examines the nature and purposes of mediation, major mediation models, the role and duties of the mediator, stages of the mediation process (preparation, opening, issue framing, option generation, caucusing, agreement drafting), and practical techniques for managing communications, power imbalances and impasse. Students study ethical and procedural questions specific to negotiation and mediation (confidentiality, disclosure, impartiality, consent and competency), legal and contractual considerations for mediated settlements, and the use of technology and online dispute resolution tools to support negotiation and mediation. The course emphasizes applied learning through simulations, role-plays and case analyses drawn from commercial, family, workplace and sectoral contexts, and is assessed by participation in practical exercises, written casework and a final analytical assignment.

To equip students with the knowledge and skills about the operation on how negotiation and mediation works.

Upon successful completion of this course, students will be able to:

- To develop an understanding of the theory and practice of negotiation in particular and conflict resolution in general;
- Explore and apply proven negotiation strategies in real-world scenarios;
- Learn how to leverage their natural negotiation style for greater effectiveness;
- Build confidence to influence and lead discussions at the mediation table;
- Acquire critical planning and analytical tools to manage various mediation settings;
- Deepen awareness of cross-cultural negotiation dynamics and how to use them to their advantage.

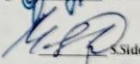

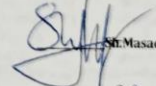
