### 1.1. Course Description

The “**Women’s Rights and Gender Equality**” course constitutes an essential component of advanced legal education, contributing to the development of independent legal reasoning, democratic values, and a comprehensive professional outlook of future legal practitioners.

The course provides an in-depth analysis of international human rights standards related to women’s rights and gender equality, as well as the mechanisms for their implementation at both international and national levels. It examines the national human rights system, legislative development trends, and institutional reforms in the context of globalization and the evolution of the information society.

Particular emphasis is placed on the protection of vulnerable groups, prevention of gender-based discrimination and violence, and the integration of gender perspectives into legal and policy frameworks.

### 1.2. Prerequisites

The course aims to develop students’ advanced understanding of women’s rights and gender equality within the framework of international and national law.

It further seeks to:

- enhance awareness of gender equality as a fundamental legal and social principle;
- provide a comprehensive understanding of international legal standards and their implementation mechanisms;
- develop analytical skills for assessing national legislation and policies;
- equip students with practical competencies to integrate gender perspectives into legal analysis, public policy, and institutional practices.

### 1.4. Learning Outcomes

Upon successful completion of the course, students will be able to:

6. **conduct** gender-sensitive legal analysis of legislation, policies, and social phenomena;
7. **interpret** and critically evaluate national and international legal instruments related to gender equality;
8. **formulate** evidence-based recommendations for integrating gender perspectives into legal and policy frameworks.

### **1.5. Independent Study and Assignments**

Independent study and take-home assignments are designed to develop students' advanced research, analytical, and practical skills. These include individual work with primary and secondary legal sources, including international treaties and legal doctrine.

Assignments involve case analysis, essay writing, and the preparation of analytical presentations.

#### **Individual Assignments**

Students are required to complete **five take-home assignments** within the established deadlines. These tasks include:

- identifying and formulating research problems in international and gender law;
- selecting appropriate research methodologies and methods;
- conducting case studies, event analysis, content analysis, and system analysis;
- carrying out field-based or empirical research where applicable;
- preparing analytical outputs, including video and poster presentations.

It further examines national human rights systems, trends in legislative development, and institutional innovations in the context of globalization and the development of the information society.

Particular emphasis is placed on contemporary developments in human rights protection, including the safeguarding of vulnerable groups requiring enhanced legal protection.

### 3.1. Course Description

The “**Customs Law**” course is designed to provide students with a comprehensive understanding of the fundamental principles, structure, and system of customs law. It focuses on the conceptual framework, legal nature, and institutional organization of customs regulation.

The course introduces students to the legal foundations of customs activity, including its role within the national legal system and its impact on economic, political, and social processes. It serves as a basis for further specialization in legal disciplines and contributes to the development of professional competencies required for legal practice in public authorities, customs bodies, law enforcement agencies, and legal services.

Particular attention is given to the interaction between customs law and international legal frameworks, as well as to the role of customs regulation in supporting economic reforms and international trade.

### 3.2. Prerequisites

No prerequisites are required for this course.

### 3.3. Course Objectives

The primary objective of the course is to equip students with a systematic understanding of the legal regulation of customs activity, including its institutional structure, regulatory mechanisms, and development trends.

The course further aims to:

- develop students’ ability to interpret and apply customs legislation;
- provide knowledge of the organization and functioning of customs authorities;
- enhance understanding of national legal frameworks and international agreements in the field of customs law;
- prepare students for professional legal activity and further academic specialization.

### 3.4. Learning Outcomes

Upon successful completion of the course, students will be able to:

1. **demonstrate** a comprehensive understanding of fundamental legal concepts, categories, and institutions relevant to customs law;
2. **analyze** the legal status of subjects of customs law and the structure of customs legal relations;
3. **apply** legal methods, including formal legal and comparative approaches, to the analysis of customs law issues;

4. **evaluate** the regulatory framework governing customs activity, including national legislation and international agreements;
5. **conduct independent research** and effectively process legal information from various sources to resolve professional legal problems;
6. **interpret and apply** customs law norms in practical legal situations;
7. **assess** the role of customs regulation in economic reforms and international trade processes;
8. **develop professional communication skills** in legal contexts, including the ability to construct reasoned legal arguments.

### 3.5. Independent Study and Assignments

Independent study is aimed at deepening students' knowledge and involves individual work with selected academic literature, including the preparation of glossaries, case analyses, analytical essays, and other written assignments.

2. evaluation criteria include independence, creativity (analytical reasoning, originality in problem-setting, and problem-solving orientation), and substantiation of arguments;
3. stylistic quality (academic literacy, clarity, coherence, and readability);
4. assignment requirements: length – 1200 words ( $\pm 10\%$ ); font – Times New Roman; line spacing – 1.5; font size – 14;
5. logical structure and consistency of presentation.

#### 4.1. Course Description

The “**Diplomatic and Consular Law**” course examines the role and place of treaty law within the system of public international law, focusing on the legal nature of international treaties and their interaction with other sources of international law.

The course covers the processes of treaty-making, including negotiation, conclusion, entry into force, application, interpretation, termination, and suspension of treaties, as well as the impact of armed conflict on treaty obligations. Special attention is given to the role of the Republic of Uzbekistan as a subject of treaty-making in international law.

The course further explores the development of diplomatic and consular law, including the evolution of diplomatic relations, privileges and immunities, and institutional frameworks governing diplomatic and consular activities.

#### 4.2. Prerequisites

No prerequisites are required for this course.

#### 4.3. Course Objectives

The course aims to develop students’ advanced competencies in international law by ensuring a deep understanding of the conceptual and categorical framework of diplomatic and consular law and its application in practice.

It further seeks to:

- analyze the development of modern international law;
- examine diplomatic law as a specialized branch of international law, including its system and features;
- explore the historical evolution of diplomatic and consular relations, including privileges and immunities;
- develop practical skills in interpreting and applying legal norms governing diplomatic and consular relations.

#### 4.4. Learning Outcomes

## **8.5. Independent Study and Assignments**

### **I. Independent Study**

- conducting empirical research, including surveys and interviews;
- preparing analytical outputs and research reports.

### 9.1. Course Description

The “**Notarial Law**” course examines legal relations arising in the course of performing notarial acts by notaries engaged in private practice, as well as by persons authorized by law to perform notarial functions.

A central focus of the course is the extra-judicial protection of subjective civil rights, including the legal nature and procedural rules governing notarial acts. The course provides a comprehensive analysis of both substantive and procedural components of notarial law.

Substantive norms define the legal status of notaries in the Republic of Uzbekistan, including their rights and obligations, as well as the role of state authorities and notarial chambers. Procedural norms regulate notarial proceedings and documentation processes.

Particular emphasis is placed on developing practical skills in drafting notarial documents and applying both substantive and procedural legal norms in professional practice.

### 9.2. Prerequisites

No prerequisites are required for this course.

### 9.3. Course Objectives

The course aims to provide students with fundamental and advanced knowledge of notarial law, ensuring a deep understanding of its conceptual framework and institutional structure.

It further seeks to:

- develop practical skills in drafting notarial documents;
- enhance students’ ability to interpret and apply legal norms in notarial practice;
- strengthen competencies in providing legal assessment and консультации in notarial matters.

### 9.4. Learning Outcomes

Upon successful completion of the course, students will be able to:

1. **demonstrate** a comprehensive understanding of the legal framework and principles of notarial law;
2. **apply** legal norms governing notarial activities to practical situations;
3. **draft and formalize** procedural and notarial documents in accordance with legal requirements;
4. **analyze and qualify** legal facts, documents, and circumstances in the context of notarial practice;

5. **formulate** written legal opinions and recommendations, including alternative legal solutions;




### **10.1. Course Description**

The elective course “**WTO Law**” provides a systematic and in-depth examination of the legal framework governing the multilateral trading system under the auspices of the World Trade Organization. The course introduces students to the foundational principles, institutional structure, and normative sources of WTO law, including the covered agreements forming the WTO legal acquis.

Particular emphasis is placed on the principles of non-discrimination (most-favoured-nation and national treatment), transparency, predictability, and trade liberalization. The course further explores the internal decision-making processes of the WTO, including negotiation dynamics, consensus-based governance, and voting mechanisms where applicable.

A core component of the course is the detailed study of the WTO dispute settlement system, enabling students to critically analyze panel and appellate reports, assess legal reasoning, and understand enforcement mechanisms within the multilateral trading regime. Through case-based learning, students engage with real-world trade disputes and develop the ability to apply WTO law in practical contexts.

### **10.2. Prerequisite(s)**

- Public International Law

This prerequisite ensures that students possess foundational knowledge of sources of international law, treaty interpretation, and the functioning of international organizations.

### **10.3. Course Objectives**

The course aims to:

- provide a comprehensive understanding of the structure and functioning of WTO law within the broader system of international economic law;
- develop students’ ability to interpret and apply WTO agreements and jurisprudence;
- equip students with analytical tools necessary to assess global trade governance and dispute resolution mechanisms;
- foster research and legal writing skills relevant to international trade law practice.

### **10.4. Learning Outcomes**

Upon successful completion of the course, students will be able to:

1. Demonstrate a systematic understanding of the principles, objectives, and institutional framework of the WTO and their impact on international trade relations;
2. Critically analyze the WTO legal framework, including multilateral trade agreements and their substantive provisions;
3. Apply WTO norms and jurisprudence to resolve complex international trade disputes and formulate legally sound arguments;
4. Conduct advanced legal research using primary sources (WTO agreements, panel and appellate body reports) and relevant scholarly literature;
5. Exercise critical thinking and problem-solving skills through case-based analysis of trade disputes;
6. Explain and evaluate WTO decision-making processes, including negotiation practices and consensus-building mechanisms;
7. Assess the effectiveness, challenges, and limitations of the WTO in regulating global trade;
8. Formulate and justify policy recommendations aimed at improving international trade governance within the WTO framework.

### **10.5. Performance Evaluation Tasks**

#### **Assessment Structure**

- Class participation and assignments — **30%**
- Mid-term examinations — **30%**
- Final examination — **40%**

Assessment methods are designed to evaluate students' doctrinal knowledge, analytical reasoning, research competence, oral advocacy, and written communication skills in line with ESG standards for student-centred learning.

#### **Class Participation (30%)**

Student performance is assessed based on active engagement, legal reasoning, and the ability to articulate arguments using appropriate legal terminology. The following formats are employed:

- **Reading Task:** Critical analysis and presentation of assigned WTO case law or academic materials;
- **Discussion Task:** Group-based examination of legal scenarios with structured questions;
- **Presentation Task:** Oral exposition of specific WTO legal concepts supported by doctrinal and practical examples;
- **Group Work Task:** Collaborative case analysis involving identification of legal issues and formulation of reasoned conclusions;

- **Legal Debate Task:** Structured adversarial discussions on controversial WTO-related issues, fostering argumentative and advocacy skills.

### **Mid-Term Examination (30%)**

The mid-term assessment is conducted in the form of independent written assignments (take-home format) during Weeks 7 and 12.

Students are required to:

- analyze hypothetical or real WTO disputes;
- identify relevant legal issues and applicable WTO provisions;
- apply WTO jurisprudence to construct coherent legal arguments;
- provide well-reasoned conclusions supported by authoritative legal sources.

### **12.1. Course Description**

The course “**International Humanitarian Law**” (IHL) constitutes a core component in the professional training of legal specialists, providing a comprehensive and systematic understanding of the legal regime applicable in situations of armed conflict.

The course examines the fundamental principles, sources, and institutional framework of IHL, with particular emphasis on the protection of victims of armed conflicts and the regulation of the conduct of hostilities. It covers the normative structure of IHL, including treaty law (notably the Geneva Conventions and their Additional Protocols) and customary international law.

Special attention is devoted to the classification of armed conflicts, the legal status of participants, the means and methods of warfare, and the interaction between IHL and international human rights law. The course also introduces students to the role and mandate of the International Red Cross and Red Crescent Movement within the international humanitarian system.

Through a combination of doctrinal analysis and case-based learning, students develop the ability to interpret and apply IHL norms in contemporary conflict scenarios.

### **12.2. Prerequisites**

- Public International Law

This prerequisite ensures foundational knowledge of international legal sources, treaty interpretation, and state responsibility.

### **12.3. Course Objectives**

The course aims to:

- develop a comprehensive understanding of the legal framework governing armed conflicts;
- ensure students’ ability to interpret and apply IHL norms in practical situations;
- foster awareness of the necessity of compliance with international legal standards protecting victims of armed conflict;

The “**International Humanitarian Law**” course is an essential component of legal education, aimed at developing both theoretical knowledge and practical competencies in the field of international humanitarian law (IHL).

The course focuses on the legal framework governing armed conflicts, including the protection of victims of armed conflicts and the regulation of the conduct of hostilities. It introduces students to the core principles, norms, and sources of IHL, as well as their application in contemporary international practice.

Particular emphasis is placed on understanding the humanitarian nature of IHL and its role in safeguarding human dignity during armed conflicts.

### 13.2. Prerequisites

Public International Law.

### 13.3. Course Objectives

The primary objective of the course is to develop students’ understanding of the necessity of compliance with legal norms regulating armed conflicts, including those aimed at protecting victims and regulating the conduct of parties to hostilities.
