## **1. Course Description**

Within the framework of the course *“Political Analysis and Its Theoretical-Methodological Foundations”*, students are introduced to the general methods and methodology of political analysis. The course covers key analytical tools such as diagnostics and forecasting, modeling and design, and familiarizes students with specialized expert techniques.

It also focuses on analyzing specific problem situations and provides practical knowledge and skills in applying both quantitative and qualitative methods. In addition, students learn to use various analytical approaches such as political modeling, event analysis, SWOT analysis, the Delphi method, and brainstorming techniques in practice.

## **2. Prerequisites**

There are no prerequisites required for this course.

## **3. Course Objectives**

The aim of the course is to provide students with fundamental political knowledge, develop competencies in political science, and ensure a deep understanding of the conceptual and categorical apparatus of the discipline, as well as its practical application.

Furthermore, the course aims to enhance students’ ability to critically evaluate contemporary international political processes and events.

## **4. Learning Outcomes**

Upon successful completion of the course, students are expected to acquire the following knowledge and skills:

1. Understand the conceptual (categorical) apparatus and methodology of political analysis;
2. Master the tools of political analysis and forecasting;
3. Distinguish between practical, theoretical, and empirical analysis and their areas of application;
4. Identify and justify political positions while maintaining objectivity in political analysis;
5. Understand and effectively apply various methods of political research;
6. Apply acquired knowledge and skills in practice;
7. Use mathematical methods in political research;
8. Acquire basic skills in political consulting and planning;
9. Evaluate political events and processes based on analytical approaches, conduct political forecasting, and make informed political decisions.

## 5. Independent Study and Assignments

I. Independent study is aimed at deepening students' knowledge of the subject and involves individual study of selected specialized literature necessary for writing essays.

The main requirements for independent work include:

- Writing essays based on assigned literature;
- Evaluation criteria: independence, creativity (analytical approach, idea generation, originality in problem formulation, focus on problem-solving), and validity of arguments;
- Stylistic quality (overall literacy, clarity, readability of the text);
- Essay length: **1200 words ( $\pm 10\%$ )**, font: *Times New Roman*, spacing: 1.5, size: 14;
- Logical structure and coherence of presentation.

II. Students must complete **5 independent assignments** in the form of individual tasks within the established deadlines. These include identifying the foundations of a political problem, selecting research methodology, applying analytical methods (event analysis, content analysis, system analysis), conducting field research (if necessary), and preparing analytical materials in the form of video or poster presentations.

All assignments must be submitted on time. Late submissions are not accepted.

## **1. Course Description**

The course *“Political Institutions and Political Processes”* is one of the specialized courses for master’s students studying in the *“International Relations”* faculty under the *“Applied Political Science”* program. The importance of this course lies in providing master’s students with an understanding of the role and significance of political institutions in implementing state policy at national, regional, and global levels. Political institutions play various roles in different political processes in society. It is essential to understand how a political system functions, how power and governance are exercised, which mechanisms are used to ensure sustainable development, and how the political system type influences these processes. Students must be able to analyze real political events theoretically and evaluate the relevance of actions taken by political institutions.

## **2. Prerequisites**

No prerequisites are required for this course.

## **3. Course Objectives**

- To provide knowledge about the main types of political institutions, the nature and types of political processes, the theoretical concepts and approaches for evaluating these processes, and the factors influencing their formation; as well as the main subjects of international relations and political processes.
- To explain the causes and nature of current processes in the changing world from a political science perspective, and their influence on the development of the political system, public political sentiment, public opinion, and the activities of national and international organizations.

Course tasks include:

- To enable master’s students to understand the main actors in political processes, both institutional and non-institutional, and to comprehend the key concepts, laws, and principles that govern current international political processes.
- To analyze political processes in different countries considering their political culture and to develop scientific approaches for forecasting and evaluating events.
- To teach the practical application of state foreign policy and branding.
- To explain the roles of political institutions and the “fourth estate” (mass media) in influencing political actors, parties, and public opinion.
- To assess the significance of election campaigns conducted in the state.

## **4. Learning Outcomes**

After successfully completing the course, students will acquire the following competencies:

- Knowledge:
  - Understand political institutions, political processes, political power, the rule of law, and types of power: legislative, executive,

- judicial; governance; institutionalization; legitimacy; plebiscitary democracy; stability; and related concepts.
  - Be aware of the existing methods for evaluating political processes.
  - Understand the significance and methods of implementing political technologies by political institution representatives.
  - Understand the principles of effective communication by political institution actors.
  - Know the role of conflictology, preventive diplomacy, and conflict resolution in evaluating current political processes.
  - Be familiar with election technologies used worldwide.
  - Understand the methods of political and diplomatic regulation, including manipulation techniques.
- Skills:
  - Recognize the main types and contents of international processes.
  - Identify forms of populism and lobbying in different countries.
- Abilities:
  - Understand political events independently.
  - Explain the diversity and contradictions in interpretations of the same political events by different actors.
  - Apply acquired knowledge to theoretical and practical political issues in debates.
- Competencies:
  - Objectively evaluate political events, considering internal and external factors.
  - Apply knowledge to theoretical and practical political issues, including analytical notes and reports.

## **5. Independent Study and Assignments**

I. Independent assignments aim to deepen students' knowledge of the course by studying selected literature and writing essays based on the main and additional sources.

Main requirements for independent work:

1. Writing essays based on assigned literature.
2. Assessment criteria: independence, creativity (analytical approach, idea development, novelty in problem statement, attention to problem-solving), justification of suggested rules.
3. Stylistic requirements: literacy, clarity of text.
4. Essay specifications: 1200 words ( $\pm 10\%$ ), font – Times New Roman, line spacing – 1.5, font size – 14.
5. Presentation consistency.

II. Students must complete 5 individual assignments on time. Tasks include identifying research foundations for political issues, selecting methodology and methods based on practical research, analyzing events, conducting content and systematic analysis, field studies, preparing analytical materials, and delivering presentations through video or poster formats.

All assignments must be submitted within the set deadlines. Late submissions will not be accepted.

## **1. Course Description**

This course is one of the modern branches of political science that studies comparative political systems. Its main objective is to develop in students a deep understanding of the current state of the discipline, its theoretical and methodological tools, key research directions, and findings.

The knowledge and skills acquired through this course are intended to contribute to students' future academic and professional activities by developing their competencies in political science and political thinking, enabling them to conduct systematic analysis of information and make rational decisions in practice.

## **2. Pre-requisites**

No prerequisites are required for this discipline.

## **3. Purpose of the Course**

This course focuses on studying similar types of political phenomena across different political systems through comparison and contrast. Such phenomena include political processes, political relations, political institutions, political regimes, political culture, political parties, movements, and others.

In addition, the course covers the study of political processes, systems and regimes, the characteristics of political space, features of political change, and the main actors of political processes. It also aims to develop students' ability to identify complex scientific problems and conduct independent research on institutional, procedural, and technological aspects of politics.

## **4. Learning Outcomes**

Upon successful completion of the course, students will be able to:

1. Understand the main categories and theories of comparative political systems;
2. Identify the specific features of modern political systems;
3. Distinguish research methods used in comparative politics;
4. Analyze comparative political systems and construct models;
5. Apply comparative analysis in practice;
6. Provide expert evaluations of modern political systems;
7. Analyze different political systems and draw practical conclusions;
8. Prepare analytical conclusions on the activities of political actors;
9. Forecast the political system of Uzbekistan based on comparative analysis;
10. Conduct research and analyze data in this field.

## 5. Independent Learning and Tasks

Independent work is carried out to deepen students' knowledge of the subject and involves individual study of selected additional literature. The forms, types, and main requirements for independent work are defined in Clause 9.

Students are required to submit five independent assignments through the electronic system within the specified deadlines. Missed assignments are not accepted for resubmission.

## Statehood in Central Asia



## **1. Course Description**

The course **“Understanding National Identity, Independence, and Modern Statehood in Central Asia”** examines the formation of national identity, the process of independence, and the concepts of state-building in the Central Asian region. The course focuses on understanding national identity within its socio-political context, analyzing political and cultural transformations that occurred during the independence period, and exploring the distinctive features of modern statehood.

Additionally, it investigates how national identity has developed historically, how it has acquired new meanings in the post-independence era, and its role in state formation, using historical, political, sociological, and cultural approaches. The course also examines the interrelations between national identity and religious, ethnic, and cultural factors. The ultimate goal is to prepare specialists capable of applying acquired knowledge in practice and assessing events and developments in a globalized world.

## **2. Prerequisites**

No prerequisites are required for this course.

## **3. Course Objectives**

The objectives of this course are to:

- Provide a deep understanding of the formation and development of national identity in Central Asia;
- Analyze political, social, and cultural transformations that occurred during the independence period;
- Introduce students to the historical roots of national identity and its political and cultural specificities;
- Examine the complex relationship between national identity and state-building;
- Develop students’ abilities to critically evaluate regional and global political processes;
- Foster a deep understanding of modern state and societal systems and the contemporary trends in shaping national identity.

## **4. Learning Outcomes**

Upon successful completion of the course, students will be able to:

1. Analyze the theoretical and practical foundations of national identity, including its historical and cultural roots;

2. Compare concepts of national identity across different periods and political contexts;
3. Examine the relationships between national identity and religious or cultural factors;
4. Assess the impact of regional and global political events and processes on national identity;
5. Conceptually analyze political and social developments occurring in Central Asia;
6. Apply general academic research methods such as analysis, synthesis, induction, critical thinking, and empirical approaches (e.g., surveys, observation), as well as systematic, comparative, and logical methods.

## **5. Independent Learning and Assignments**

### **I. Independent Work**

Independent work is aimed at deepening students' knowledge and involves individually studying key and supplementary literature to prepare an essay. Key requirements include:

1. Writing an essay based on the assigned literature;
2. Evaluation criteria: independence, creativity (analytical approach, idea formation, novelty in problem formulation, focus on problem-solving), and validity of proposed arguments;
3. Style and readability of the text;
4. Essay specifications: approximately 1200 words ( $\pm 10\%$ ), Times New Roman, 14 pt, line spacing 1.5;
5. Coherence and structure of the submission.

### **II. Assignment Requirements**

Students must complete 5 independent assignments on time, including:

- Identifying research foundations of political problems;
- Selecting methodology, methods, and research techniques based on practical research;
- Event analysis, content analysis, systematic analysis, field research;
- Preparing analytical materials in written, video, or poster presentation formats.

All assignments must be submitted by the deadline. Late submissions will not be accepted.



## **1. Course Description**

This course examines the role of religion in international relations, focusing on the influence and role of Islam in contemporary political processes. It aims to prepare specialists who can apply their knowledge in practice and assess current events and developments in modern political processes.

## **3. Course Objectives**

The course aims to:

- Teach students the impact of religious factors in the international arena;
- Develop competencies related to the subject matter;
- Provide a deep understanding of the categorical apparatus of the field;
- Enable students to apply this knowledge in practice;
- Cultivate the ability to critically assess events and developments in contemporary international political and religious processes.

## **4. Learning Outcomes**

Upon successful completion of the course, students will be able to:

1. Have a comprehensive understanding of the causes behind global religion-related events and changes.
2. Understand the essence of international and regional events and the significance of their national, regional, and global manifestations.
3. Comprehend religious-political processes occurring within the scope of international relations.
4. Apply theoretical knowledge to evaluate religious-political events and developments.
5. Utilize general scientific methods such as analysis, synthesis, induction, empirical methods (surveys, observation, document analysis), systematic and comparative methods.

## **5. Independent Study and Assignments**

I. Independent work is intended to deepen students' knowledge in this subject. It involves individually studying core and supplementary literature and writing an essay based on selected readings.

Requirements for this type of assignment include:

1. Writing an essay based on the literature provided for independent study;
2. Assessment criteria: independence, creativity (analytical approach, idea formation, novelty of problem definition, focus on problem-solving), and validity of proposed arguments;
3. Style: literacy, clarity, and ease of understanding;
4. Essay format: 1200 words ( $\pm 10\%$ ), Times New Roman, 1.5 line spacing, font size 14;
5. Consistency in presentation.

II. Students must complete five independent assignments individually by the deadline. Tasks may include: identifying the foundations of political problems, selecting methodology, methods, and research tools based on practical research, event analysis, content analysis, systematic analysis, conducting field studies, preparing analytical materials, and presenting them via video or poster presentations.

All assignments must be submitted on time; late submissions are not accepted.
