1. Course Description

The course *“Public Service and Governance”* provides graduate students with essential knowledge and practical skills related to the key concepts of public service and administration. It covers the system and institutions of public administration in Uzbekistan, organization and management of public service, legal status of civil servants and recruitment procedures, personnel policy and кадров reserves, strategic planning and decision-making processes, and systems for evaluating public service performance.

The course also addresses issues such as career progression, incentives and disciplinary measures, termination of service and legal-social protection, anti-corruption measures and conflict of interest management, ethical standards and service culture, public relations and transparency in governance, as well as recent reforms and new institutional frameworks. The program aims to ensure both theoretical understanding and practical application of these areas.

2. Prerequisites

There are no prerequisites required for this course.

3. Course Objectives

The objectives of the course are:

- To provide a systematic understanding of the essence, goals, and functions of public service and governance;
- To equip graduate students with the fundamental knowledge and skills necessary for professional activity in public and civil service;
- To familiarize students with various types of activities related to public service and to provide knowledge about the professional and ethical responsibilities of civil servants.

4. Learning Outcomes

Upon successful completion of this course, graduate students will be able to:

- Analyze the goals and functions of public service and governance;
- Correctly interpret and apply the legal framework governing public civil service;
- Demonstrate competencies in preventing corruption, managing conflicts of interest, and adhering to ethical standards in public and civil service.

5. Independent Study and Assignments

I. Independent work is aimed at deepening students' knowledge of the subject and involves individual study of selected specialized literature necessary for preparing analytical reports and presentations.

Key requirements include:

1. Preparation of an **analytical report and presentation** on an assigned topic;
2. Evaluation criteria: independence, use of international experience (analytical approach, idea development, originality in problem formulation, focus on solutions), and validity of proposed arguments;
3. Style and formatting (general literacy, clarity, readability, and overall presentation of the document);
4. Report length: **2–3 pages**, font size 14, line spacing 1.5;
5. Presentation length: **8–10 slides**;
6. Logical structure and coherence of the presentation.

II. Graduate students must complete and submit **4 independent assignments** in the form of individual tasks within the established deadlines.

1. Course Description

The course *“Legal Foundations of Public Administration”* provides master’s students with knowledge and skills related to the essence and principles of public administration, the constitutional foundations of the organization of state power in the Republic of Uzbekistan, and the principle of separation of powers. It covers the legal status and competencies of public administration bodies, including the Oliy Majlis (Parliament), the President, and the Cabinet of Ministers, as well as the legal framework for the organization and structure of the judiciary and the prosecutor’s office.

The course also examines the legal norms regulating the activities of local government authorities, the system of electoral legislation in Uzbekistan, and issues related to its improvement.

2. Prerequisites

No prerequisites are required for this course.

3. Course Objectives

The objectives of this course are:

- To provide master’s students with a systematic understanding of the content and legal foundations of public administration, as well as its key issues, goals, and tasks;
- To equip students with the essential knowledge and skills necessary for professional activity in the field of public administration;
- To familiarize students with various types of activities related to the legal regulation of public administration.

4. Learning Outcomes

Upon successful completion of this course, students will be able to:

- Develop managerial decisions and analyze legal issues related to public administration;
- Apply and correctly interpret legislation related to public administration;
- Prevent corruption in public administration, manage conflicts of interest, and adhere to ethical standards;
- Effectively cooperate with public authorities, law enforcement agencies, and supervisory bodies.

5. Independent Study and Assignments

I. Independent study is aimed at deepening students' knowledge of the course and involves individual study of primary and supplementary literature, as well as нормативно-правовые документы (normative legal documents), in order to prepare analytical reports.

The main requirements for independent work are:

1. Preparation of an analytical report and a management decision based on the assigned topic;
2. Assessment criteria include independence, creativity (analytical thinking, idea generation, novelty in problem formulation, focus on problem-solving), and justification of proposed solutions;
3. Writing quality (general literacy, clarity, and readability of the text);
4. The analytical report should be 2–3 pages in length, typed in Times New Roman, font size 14, with 1.5 line spacing, and logically structured.

II. Master's students must complete and submit **three independent assignments** in the form of individual tasks within the specified deadlines.

1. Course Description

The course "*Sociology and Psychology of Management*" examines politics as a sphere of social life and provides an understanding of the socio-economic foundations of politics. It explores the socio-political stratification of social systems, the levels and structure of political consciousness, and the interaction between politics and society.

The course also analyzes the interrelationship between social relations (the social sphere) and political institutions, enabling students to understand the dynamics of their mutual influence.

2. Prerequisites

No prerequisites are required for this course.

3. Course Objectives

The objective of this course is to develop in master's students the ability to scientifically analyze the social and psychological foundations of management processes, as well as the mechanisms of interaction between individuals and groups, and to apply this knowledge in practice.

4. Learning Outcomes

Upon successful completion of the course, students will:

- Acquire knowledge of sociological and psychological theories of management;
- Learn methods for analyzing relationships between leaders and teams;
- Understand the role of individuals and groups in social processes;
- Gain knowledge of conflict management and communication processes;
- Be able to identify ways to improve the effectiveness of the human factor in management.

5. Independent Study and Assignments

Students are required to complete and submit independent assignments within the specified deadlines. Independent work includes essays, analytical papers, reviews, case studies, and presentations.

All assignments must be uploaded to the JIDU Moodle platform and will be assessed according to established evaluation criteria. Presentations must be delivered in front of the class; however, no separate marks are allocated for the Q&A session.

At the end of the course, students must complete an individual project in the form of a scientific article or a small research study. The topic must be agreed upon and approved by the instructor; otherwise, the maximum score for the assignment will be limited to 20%.

1. Course Description

The course “*National Security*” provides master’s students with knowledge and skills related to the concept and essence of national security, as well as the constitutional foundations for ensuring national security in the Republic of Uzbekistan.

It covers the subjects and objects of security, and methods for identifying, assessing, and analyzing threats and risks to the vital interests of the individual, society, and the state. The course also focuses on developing and improving analytical approaches in the field of national security.

2. Prerequisites

No prerequisites are required for this course.

3. Course Objectives

The objective of the course is to develop theoretical knowledge among master’s students in the field of national security, as well as to equip them with the ability to apply this knowledge in practice, particularly in analyzing potential risks and threats that may arise in emergency or critical situations.

4. Learning Outcomes

Upon successful completion of this course, students will be able to:

- Apply and correctly interpret legislation related to ensuring security;
- Identify, assess, and analyze threats and risks to the vital interests of individuals, society, and the state;
- Understand and evaluate the role and place of state institutions, political parties, non-governmental organizations, public associations, and individuals in ensuring national security.

5. Independent Study and Assignments

I. Independent study is aimed at deepening students’ knowledge of the course and involves individual study of primary and supplementary literature, as well as normative legal documents, in order to prepare analytical reports.

The main requirements for independent work are:

The course "*Contemporary Politics of Uzbekistan*" examines the country's domestic and foreign policy as an integrated system. It provides an understanding of the social, economic, and political foundations of contemporary politics, the specific features of political systems and regimes, and the activities of political actors.

The course also explores the interaction between politics and society, including aspects of youth and religious policies, as well as the relationships among political institutions.

2. Prerequisites

No prerequisites are required for this course.

3. Course Objectives

The objective of the course is to develop in master's students the ability to scientifically analyze the main directions of Uzbekistan's contemporary policy, including the functioning of state institutions and other actors of power, as well as the interconnection and mechanisms of interaction between domestic and foreign policy, and to apply this knowledge in practice.

4. Learning Outcomes

Upon successful completion of the course, students will be able to:

- Identify problems, set management objectives, propose solutions, evaluate results, and take into account the consequences of managerial decisions;
- Understand the characteristics of the political system, political processes, and contemporary political regimes;
- Demonstrate knowledge of the specific features of the presidency and executive power institutions;
- Understand the characteristics of modern parliamentarism;
- Analyze the formation and functioning of political parties and understand the party system of the country;
- Explain the features of the formation and evolution of civil society in Uzbekistan;
- Understand the specifics of local self-government institutions;
- Critically analyze the main directions of Uzbekistan's contemporary domestic and foreign policy.

5. Independent Study and Assignments

Students are required to complete and submit independent assignments within the specified deadlines. Independent work includes essays, analytical papers, reviews, case studies, and presentations.

All assignments must be uploaded to the JIDU Moodle platform and will be assessed according to established evaluation criteria. Presentations must be delivered in front of the class; however, no separate marks are allocated for the Q&A session.

At the end of the course, students must complete an individual project in the form of a scientific article or a small research study. The topic must be agreed upon and approved by the instructor; otherwise, the maximum score for the assignment will be limited to 20%.

1. Course Description

In contemporary politics, corporate power refers to the field that serves to foster understanding and goodwill among individuals, organizations, groups of people, or society at large through the dissemination of explanatory materials, information exchange, and assessment of public reactions.

This course enables master's students to accurately understand the essence of today's complex political processes, analyze political developments in society, comprehend the formation of political awareness among the public, and make informed assessments of rapidly changing political events.

2. Prerequisites

There are no prerequisites for this course.

3. Course Objectives

The course aims to develop master's students' competencies in corporate power in contemporary politics, provide a deep understanding of the categorical apparatus of the field, enable its practical application, and cultivate the ability to critically evaluate events and developments occurring in contemporary international political processes.

4. Learning Outcomes

Upon successful completion of this course, students will be able to:

1. Analyze the influence of corporate interests on political processes and make informed decisions.
2. Conduct qualitative and quantitative research, collect and interpret data on corporate power.
3. Evaluate different perspectives and evidence regarding the influence of corporations on politics.
4. Express their ideas clearly and confidently in writing and orally, including public speaking skills.
5. Communicate effectively with various stakeholders, including businesses, governments, and public organizations.
6. Understand the legal aspects of corporate politics, including regulation of lobbying.
7. Address ethical issues related to corporate power and its societal impact.
8. Develop strategies for operating in environments shaped by corporate influence on politics.
9. Integrate knowledge from various fields (economics, sociology, political science) to better understand the topic.

10. Plan and implement projects related to the study of corporate power and its political influence.

5. Independent Study and Assignments

I. Independent work is aimed at deepening the student's knowledge of this subject and involves individual study of primary and supplementary literature to write an essay.

The main requirements for this type of assignment are:

1. Writing an essay based on the literature provided for independent study;
2. Evaluation criteria: independence, creativity (analytical approach, idea formation, novelty of problem definition, focus on problem-solving), and validity of proposed arguments;
3. Style (overall literacy, clarity of the text);
4. Essay format: 1200 words ($\pm 10\%$), Times New Roman, 1.5 line spacing, font size 14;
5. Consistency of presentation.

II. Students must complete five independent assignments individually by the deadline, which may include: identifying the foundations of a political problem, selecting methodology, methods, and research tools based on practical research, event analysis, content analysis, systematic analysis, field research, preparing analytical materials, and presenting them via video or poster presentations.

All assignments must be submitted on time. Late submissions are not permitted.

1. Course Description

This lecture course is designed to familiarize students with the main theoretical concepts and processes in the field of system analysis and managerial decision-making, with a particular focus on social and humanitarian approaches. Students will explore systems as social constructs at macro, meso, and micro levels, and examine the factors influencing decision-making processes within societies, organizations, communities, and individual actors.

The course covers classical and contemporary sociological theories, behavioral economics, network analysis, artificial intelligence, and digital spaces, including virtual worlds and online platforms. It emphasizes understanding how decisions are shaped by social structures, cultural norms, individual motivations, and technological factors. By the end of the course, students will be able to analyze complex social systems and make informed managerial decisions in dynamic and uncertain contexts.

2.Pre-requisites

Prerequisites for this discipline are not required.

3. Purpose of the course

The course aims to provide students with theoretical and practical skills to understand and analyze social systems and the processes of managerial decision-making at multiple levels. Students will develop the ability to evaluate the impact of social, cultural, organizational, and technological factors on decision-making, and to formulate strategic, tactical, and adaptive recommendations for effective management.

4.Learning outcomes

Upon successful completion of this course, students should be able to:

1. Understand the concept of system analysis and systems as social constructs.
2. Analyze systems at macro (societies, states, civilizations), meso (organizations, networks, communities), and micro (individuals, small groups) levels.
3. Apply classical and contemporary sociological theories to understand decision-making processes.
4. Assess the impact of culture, norms, ideology, and social structures on managerial decisions.
5. Recognize the role of behavioral economics and cognitive biases in individual and group decision-making.
6. Understand the applications and limitations of artificial intelligence in system analysis and decision-making.
7. Analyze virtual and digital spaces as social systems using concepts such as rhizomes, assemblages, actor-network theory, and flat ontologies.
8. Apply system analysis methods to real-world managerial challenges at different organizational and societal levels.

9. Evaluate ethical, social, and technological implications of decisions in digital and physical environments.
10. Develop strategic recommendations and adaptive solutions for managerial and organizational decision-making

5. Independent learning and tasks
