1. Course Description

Within the “Comparative Contract Law” course, master's students are offered an introduction to contract law from a comparative perspective. During the course, the fundamental rules and principles of contract law are studied and analysed comparatively through the example of various legal systems. This course discusses topics such as contract formation, interpretation, unconscionable terms, the general principles of breach of contract, and remedies, drawing on the legal systems of the Anglo-Saxon, Romano-Germanic, and continental European jurisdictions, among others. Students will acquire practical skills by mastering contract law principles across various legal systems. Furthermore, the course is designed to address practical issues and develop theoretical projects, taking into account the harmonisation trends of contract law across various fields.

2. Course Prerequisites

No prerequisites are required for this course.

3. Course Aims

Postgraduate students will develop theoretical knowledge and practical skills in this area: they will acquire knowledge of the nature of the contract under the Anglo-Saxon and Romano-Germanic systems, its role in society, and the principles of its regulation.

4. Learning outcomes

Upon successful completion of this course, master's students will have acquired the following skills:

1. To enhance their knowledge and professional skills in the field of contract law within various legal systems, and to teach them how to apply these in both academic and practical settings;
2. to acquire knowledge of the foundations of continental European contract law in the Anglo-Saxon and Romano-Germanic systems, including its concepts, types and contractual terms;
3. to acquire knowledge of the fundamentals of contract law in Germany, the United Kingdom, the USA, Allows for the identification of the main similarities and differences between French and European contract law;
4. Development of practical skills in the conclusion, amendment and termination of contracts in the Anglo-Saxon and Romano-Germanic systems of continental European states;
5. Solving cases related to the Anglo-Saxon and Romano-Germanic systems, and those of continental European countries;
6. Analysing and presenting case law from the Anglo-Saxon system;
7. Analysing and expertising contracts from the Anglo-Saxon, Romano-Germanic and continental European systems;
8. To analyse the national legislation of various countries on contracts and to formulate proposals.

5. Independent Study and Independent Work

I. Independent work for master's students of this subject This is undertaken to deepen the students' knowledge of the subject and involves the independent study of primary and supplementary literature required to write and present a project on a pre-selected topic.

The main requirements for this form of independent work for master's students are as follows: (1) to write a project on the topic selected for independent study (in accordance with the specified requirements); (2) In assessing the work, the following are taken into account: independence, a comparative analytical approach, and substantiated recommendations; (3) stylistics (overall literacy, clarity of text comprehension); and (4) presentation.

II. The master's student must submit the project work by the specified deadline. Late submission of the project work is not permitted.

1. Course Description

The course introduces students to mediation and international commercial arbitration, legal regulation of international commercial arbitration, including arbitration agreement, establishment of arbitral tribunals, jurisdiction and powers of arbitral tribunals, arbitration proceedings, the nature of partial and final arbitral awards, recognition and enforcement of arbitral awards, the New York Convention on Recognition and Enforcement of Foreign Arbitral Awards (1958), the Law of the Republic of Uzbekistan on International Commercial Arbitration (2021), arbitration rules of arbitration institutions.

2. Course Prerequisites

None

3. Course Objectives

To equip students with the knowledge and skills about the operation of international commercial arbitration and mediation.

4. Learning Outcomes

Upon successful completion of this course, students will be able to:

- Understand mediation and international commercial arbitration process;
- Analyze international commercial arbitration cases;
- Apply the rules of the New York Convention on Recognition and Enforcement of Foreign Arbitral Awards (1958);
- Apply the rules of the Law of the Republic of Uzbekistan on International Commercial Arbitration (2021);
- Use and apply arbitration rules of arbitration institutions.

5. Independent Study and Assignments

Independent work is assigned to enhance students' practical understanding of international commercial arbitration through the application of legal concepts to real or hypothetical scenarios. This component of the course involves the individual analysis of selected case studies and the preparation of structured presentations based on those analyses.

Students are expected to engage in independent research and critical thinking while working on a case. The tasks require identifying key legal issues, interpreting relevant contract provisions, and evaluating dispute resolution mechanisms. Presentations must demonstrate clarity, legal reasoning, and the ability to communicate complex ideas effectively.

All assignments must be submitted on time. Late submissions will not be accepted, and resubmission is not allowed under any circumstances.

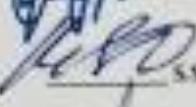

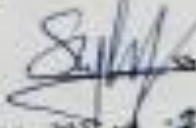

1. Course Description

In the "International Investment Law" course, master's students will develop knowledge regarding the essence, concept, and sources of the discipline of international investment law. The course aims to form an understanding of the theoretical foundations of international investment law and the content of its main institutions, as well as to provide clear and systematic knowledge of international investment law. It will assist master's students in writing their dissertations and scholarly articles on topics related to international investments. Furthermore, it provides guidance in identifying problems in academic writing and developing solutions to address them.

2. Course Prerequisites

No course prerequisites are required.

3. Course Objectives

Master's students will develop theoretical knowledge and practical skills in this field, including: providing theoretical knowledge on the fundamental concepts and principles of the discipline of international investment law; acquiring information on conflict of laws rules governing international investment legal relations; and concluding and regulating international investment contracts. The course is aimed at developing master's students' knowledge of international instruments relating to international investments and forming their practical skills in this regard.

4. Learning outcomes

Master's students will acquire knowledge in the following areas:

- Acquire knowledge of the concept, subject matter, and sources of international investment law;
- Acquire knowledge of the subjects of international investment law;
- Develop an understanding of the principles of international investment law;
- Acquire knowledge of the concept and types of investment guarantees;
- Acquire knowledge of the regulation of investment activities within the framework of international and regional cooperation;
- Acquire knowledge and skills regarding the legal regulation of specific types of investment activities;
- Develop practical skills in drafting, analyzing, and conducting expert reviews of investment contracts;
- Analyze investment legislation and develop proposals.

5. Independent Study and Assignments

I. Independent study is conducted with the aim of deepening master's students' knowledge in this discipline and involves individual study of primary and supplementary literature necessary for writing and presenting a project paper on a pre-selected topic.

The main requirements for this form of independent study for master's students are as follows: (1) writing a project paper on a topic selected for independent study (in accordance with the specified requirements); (2) the assessment of the work shall take into account: independence, a comparative analytical approach, and the provision of well-founded proposals; (3) stylistic presentation (overall literacy, clarity and comprehensibility of the text); and (4) delivering a presentation.

II. The master's student must submit the project paper as part of the independent study no later than the specified deadline.

Late submission of the project paper shall not be permitted.

1. Course description

The "Competition Law" course introduces graduate students with the freedom of activity of business entities, the essence and significance of free competition in the conditions of market relations, the concept of competition law.

The course covers the system of legal foundations for ensuring competition, the organizational and legal system of ensuring competition, the concept and tasks of competition law.

Students will explore regulatory legislation designed to restrict monopolistic activities and natural monopoly, the role of advertising in competition of business entities, responsibility for violation of competition law.

As a 4-credit course, it emphasizes both theoretical understanding and practical application of legal rules in business contexts, aiming to equip students with essential legal knowledge for future professional activities.

2. Early requisites of Course

No prerequisites are required for this subject.

3. Course objectives

Introduce students to the basic terms such as "relevant market," "dominant position," and "economic concentration" within the legal framework of Uzbekistan.

Distinguish between monopoly, oligopoly, and competitive markets to understand the state's regulatory role.

Explain and classify "horizontal" (cartels) and "vertical" agreements that fix prices or restrict trade.

Recognize when a company has a "dominant position" and identify behaviors that constitute an "abuse" of that power.

Develop understanding of legal "red lines" for government bodies to prevent unfair preferences or state-led monopolies.

Understand the mandatory "Competition Impact Assessment" process for new laws and government subsidies.

Learn the procedural rules for financial sanctions, the "Leniency Program," and judicial appeals.

Solve real-world by applying the provisions of the Law "On Competition."

4. Learning Outcomes

Upon successful completion of this discipline, undergraduates acquire the following skills:

1. Formation of fundamental knowledge in students in competition law;
2. Develop skills in the preparation of legal documents;
3. Development of skills in identifying and applying legislation to problematic situational tasks;
4. Development of legally grounded skills for answering logical questions;
5. Development skills of giving advice to entrepreneurs on competition law;

5. Independent Study and assignments

I. Independent Study

Independent study is aimed at strengthening students' understanding of business law concepts and developing practical skills. Given that the course carries 4 credits, students are expected to engage actively in self-study.

Students are required to:

1. Prepare a project or case analysis on a selected competition law topic;
2. Study primary legal sources and relevant literature;
3. Apply legal principles to practical situations;
4. Present clear and well-structured written work;
5. Deliver an oral presentation.

1. Course Description

Within the framework of this discipline, the fundamental basis for the reorganization of business entities and the legal regulation of insolvency, their forms and directions, in the form of a merger, acquisition, division, spin-off, transformation of a legal entity, the concept of insolvency, its features, the legal status of participants in bankruptcy cases, the bankruptcy trustee, the creditors' meeting, the procedure for satisfying creditors' claims, subsidiary liability applied as a result of insolvency, transnational insolvency (bankruptcy) were developed in order to study the legal basis.

2. Course Prerequisites

No formal prerequisites are required.

3. Course Objectives

Teaching master's students the basics of business reorganization and insolvency in this area, forming their competencies in this area, ensuring a deep understanding of the conceptual apparatus of science and the correct application of this knowledge in practice.

4. Learning Outcomes

- Upon successful completion of this subject, master's students will acquire the following skills:
- formation of fundamental knowledge among students on business reorganization and bankruptcy;
- formation of skills in drawing up legal documents (constituent documents, contracts, protocols, claims, etc.);
- formation of skills in identifying and applying legislative acts to problem situations;
- Formation of the ability to give legally justified answers to logical questions;
- formation of skills in advising entrepreneurs on legal issues of business reorganization and bankruptcy;
- assistance to students in obtaining knowledge through independent study.

5. Independent Study and Assignments

I. Independent work is conducted to deepen master's students' knowledge of this subject and involves the individual study of primary and supplementary literature required for writing and presenting a project on a pre-selected topic.

The main requirements for this form of independent work for master's students are as follows: (1) writing a project on the chosen topic for independent study (in accordance with established requirements); (2) the evaluation of the work will take into account the following: independence, a comparative-analytical approach, and the provision of well-founded recommendations; (3) stylistics (general literacy, clarity of the text); (4) and a presentation.

II. The master's student must submit the project for their independent work no later than the specified deadline.

1. COURSE CONTENT

The course "*International Intellectual Property Law*" is aimed at studying the legal norms and institutions governing the field of intellectual property, as well as the general principles of legal regulation in the protection of the results of intellectual activity. The course also examines the main trends and patterns in the development of civil legislation regulating intellectual property objects and the rules for their protection in the Republic of Uzbekistan. The significance of international intellectual property law lies in the fact that considerable attention is paid to the comprehensive protection of intellectual property objects, which serve as a form of private property.

The main objectives of the course are:

- to study key legal documents of the legislation on intellectual property;
- to become familiar with the history and modern trends of international intellectual property law;
- to develop the ability to make independent decisions based on the legislation of the Republic of Uzbekistan and foreign countries;
- to cultivate the skills of examining different areas of intellectual property law from a comparative perspective.

The course will enable master's students to correctly interpret court decisions, analyze them, and form their own well-reasoned conclusions.

2. PREREQUISITES

No prerequisites are required for this course.

3. COURSE OBJECTIVE

The main goal of the course is to study the key legal instruments of international intellectual property law, to become familiar with the development of international intellectual property law and its current trends, to acquire the ability to make independent decisions based on the legislation of the Republic of Uzbekistan, and to learn how to approach various areas of international intellectual property law from a comparative perspective, among other objectives.

4. LEARNING OUTCOMES

Upon successful completion of this course, master's students will acquire the following knowledge and skills:

- To understand the main concepts of international intellectual property law, correctly identify the applicable legal norms for addressing specific issues, and accurately use legal terminology;
- To independently prepare written recommendations outlining possible solutions to problems in international intellectual property law;
- To analyze primary and secondary sources of international intellectual property law, as well as scholarly literature studied within the course;
- To independently draft legal documents, including procedural documents and intellectual property agreements;

- To independently apply the acquired knowledge, skills, and competencies to simulated or real-life situations;
- To provide competent legal advice through an informed evaluation of the situation concerning a given problem.

5. INDEPENDENT STUDY AND SELF-DIRECTED WORK

I. Independent work is conducted with the aim of deepening master's students' knowledge of the subject and involves individual study of the main and supplementary literature necessary for completing independent assignments based on pre-selected specialized sources.

II. The main requirements for this form of independent work for master's students are as follows:

1. Completion of assignments based on the literature provided for independent study;
2. Assessment criteria include: independence, creativity (analytical approach, idea generation, novelty in problem formulation, attention to problem-solving), and the justification of proposed solutions;
3. Style and presentation (overall literacy, clarity, and readability of the text);
4. Essay requirements: length – 1,200 words ($\pm 10\%$); font – Times New Roman; line spacing – 1.5; font size – 14;
5. Logical sequence and substantiation of the arguments presented.

III. Each master's student must complete five independent assignments in the form of individual tasks by the specified deadlines (case study solutions on previously covered topics, document templates, comparative analyses).

Master's students are required to submit all assignments on time. Missed assignments cannot be resubmitted.

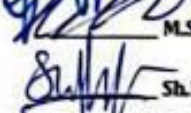

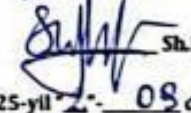

1. Course Description

The "Corporate Law" course provides master's students with in-depth knowledge of the legal regulation of corporate entities, their formation, governance, and operation in both national and international contexts. The course examines the legal nature of corporations, corporate personality, and the rights and obligations of shareholders, directors, and other stakeholders.

It covers key aspects such as corporate governance, fiduciary duties, shareholder rights, corporate finance, mergers and acquisitions, and corporate restructuring. The course also explores comparative approaches to corporate regulation and contemporary issues in corporate law. Special attention is given to developing analytical and practical skills in applying corporate law in real-life situations, drafting corporate documents, and resolving corporate disputes. As a 6-credit course, it requires intensive study, active participation, and substantial independent work.

2. Course Prerequisites

No formal prerequisites are required. However, prior knowledge of civil law, business law, and contract law is highly recommended.

3. Course Objectives

The course aims to:

- Provide comprehensive knowledge of the concept and legal framework of corporate law;
- Explain the formation, registration, and dissolution of corporate entities;
- Develop understanding of corporate governance mechanisms;
- Analyze the rights and duties of shareholders, directors, and executives;
- Introduce legal aspects of corporate finance and capital structure;
- Provide knowledge on mergers, acquisitions, and corporate restructuring;
- Develop skills in drafting corporate documents (charters, shareholder agreements, resolutions);
- Enhance students' ability to resolve corporate disputes and analyze case law;
- Prepare students for professional legal practice in corporate and business law.

4. Learning Outcomes

Upon successful completion of the course, students will be able to:

- Understand the concept, sources, and principles of corporate law;
- Identify different types of corporate entities and their legal features;
- Analyze corporate governance structures and mechanisms;
- Evaluate the rights and obligations of shareholders and directors;
- Apply legal rules to issues of corporate finance and transactions;
- Draft corporate legal documents and internal regulations;
- Analyze mergers, acquisitions, and restructuring processes;
- Resolve corporate disputes using legal reasoning;
- Critically assess corporate legislation and propose improvements.

5. Independent Study and Assignments

I. Independent Study

Independent study is designed to deepen students' knowledge and develop research and analytical skills. Given that the course carries 6 credits, students are expected to devote substantial time to independent learning.

Students are required to:

1. Prepare a research/project paper on a selected topic in corporate law;
2. Use comparative and analytical approaches;
3. Provide well-grounded legal arguments and practical recommendations;
4. Follow academic writing standards (clarity, structure, referencing);
5. Present their research findings in class.

II. Submission Requirements

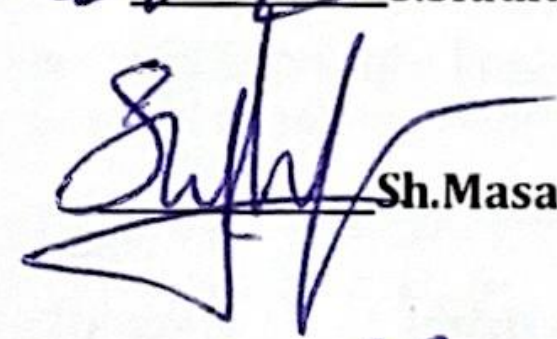

1. Course Description

This course covers the nature of transactions widely used in international commercial transactions and the issues of their contractual legal regulation. Students will acquire the theoretical and practical skills to draft various contracts used in international commercial relations. This will assist them in writing their chosen dissertation and academic papers on the topic of international commercial contracts. It also provides guidance on identifying problems for a research paper and developing proposals for their solution.

2. Course Prerequisites

No prerequisites are required for this course.

3. Course Aims

The aim of the course is to equip postgraduate students with the skills to understand the nature of international commercial contracts, their contractual legal regulation, and their practical application.

4. Learning Outcomes

Upon successful completion of this module, students will have acquired the following skills:

1. An understanding of the legal nature and types of international commercial contracts and their regulation under international law;
2. develop practical skills in analysing, drafting, performing and terminating the terms of international commercial contracts;
3. understand the rights, obligations and liabilities of the parties in various contracts;
4. conduct analysis and expert review of international commercial contracts;
5. distinguish between types of international commercial contracts;
6. acquire knowledge of the legal regulation of international commercial contracts;
7. to develop legislative proposals on topics relating to international commercial contracts and to conduct comparative analysis.

5. Independent Study and Independent Work

I. Independent work for master's students of this subject carried out with the aim of deepening students' knowledge of the subject, and involves the independent study of primary and supplementary literature required to write and present a project on a pre-selected topic.

The main requirements for this form of independent work for master's students are as follows: (1) to write a project on the topic selected for independent study (in accordance with the specified requirements); (2) In assessing the work, the following are taken into account: independence, a comparative analytical approach, and substantiated recommendations; (3) stylistics (overall literacy, clarity of text

comprehension); and (4) presentation.

II. The master's student must submit the project work by the specified deadline. Late submission of the project work is not permitted.

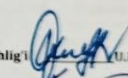

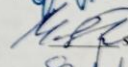

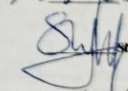
