REGULATION

of the Students’ Council
of the University of World Economy and Diplomacy

I. General Provisions

1. The Students’ Council of the University of World Economy and Diplomacy (hereinafter referred to as the *Students’ Council*) is an independent body of student self-governance and is accountable to the General Assembly of Students.
2. In its activities, the Students’ Council is guided by the Constitution and laws of the Republic of Uzbekistan, relevant regulatory legal acts, the Charter of the University of World Economy and Diplomacy, and this Regulation.
3. The term of office of the Students’ Council is one (1) year. Until a new convocation is formed, the current Council shall continue its activities.
4. The Students’ Council has its own logo, badge insignia for members, and identification cards of an установленный (established) form.
5. Official name of the Students’ Council:
 - Full name: *Students’ Council of the University of World Economy and Diplomacy*;
 - Abbreviated name: *Students’ Council*;
 - In English: *Students Council of the University of World Economy and Diplomacy*;
 - In Russian: full name — *Студенческий совет Университета мировой экономики и дипломатии*; abbreviated name — *Студенческий совет*.

II. Goals and Objectives of the Council

6. The goals of the Students’ Council are:
 - supporting students;
 - increasing legal awareness and legal literacy;
 - forming an active civic and political position among youth;
 - protecting the rights and legitimate interests of students;
 - strengthening the cultural, educational, spiritual, and moral environment at the University;
 - developing social activity, leadership qualities, initiative, and organizational skills among students;
 - ensuring active student participation in the internal life of the University.

7. The main objectives of the Students' Council are:

- 7.1. developing proposals to protect the rights and legitimate interests of students;
- 7.2. increasing students' political literacy and cooperation with representative bodies;
- 7.3. raising awareness of the Council's activities and legislative processes;
- 7.4. engaging youth in legislative and law-making activities;
- 7.5. developing effective mechanisms for the prevention of offenses among students;
- 7.6. improving legal culture and expanding the intellectual, spiritual, moral, aesthetic, and artistic outlook of students;
- 7.7. studying student-related issues and preparing proposals for their resolution.

III. Rights of the Council

8. The Students' Council has the right to:
- 8.1. participate in University meetings and sessions;
 - 8.2. express opinions and put forward initiatives on behalf of students;
 - 8.3. cooperate, in accordance with established procedures, with international and foreign organizations;
 - 8.4. finance its activities from sources not prohibited by legislation.

IV. Board of Trustees

9. The Board of Trustees is a consultative body with broad powers that determines the strategic directions of the Students' Council's activities, supports its projects and initiatives, and develops cooperation with the University administration.
10. The Board of Trustees consists of five (5) members:
- the Chairperson of the Students' Council (Chairperson);
 - the First Vice-Rector for Youth Affairs and Spiritual-Educational Work;
 - the Head of the Youth Office;
 - a representative of the "Honorary Members of the Students' Council";
 - a representative of the Alumni Association.
11. Each year, a Secretary is elected from among the members of the Board.
12. The Board of Trustees reviews and provides recommendations on the following issues:
- the annual work plan and draft budget;
 - major projects and initiatives;
 - effectiveness of activities and organizational structure;
 - internal regulatory documents;

- interaction with the University administration;
- implementation of international best practices in student self-governance.

V. Procedure for Electing the Chairperson of the Council

13. Elections of the Chairperson of the Students' Council are conducted by the Election Commission.
14. Members of the Election Commission are elected from among students at an open meeting of the Students' Council for the period of the elections. The University administration and members of the Board of Trustees participate as observers.
15. To organize and conduct elections, a working group of the Election Commission shall be formed no later than 15 days prior to the election date.
16. Elections shall be announced no later than two months before the expiration of the term of office of the Chairperson of the previous convocation.
17. Candidates may be students of the 2nd or 3rd year who submit a written application to the Election Commission.
18. At the first stage, candidates are invited for an interview. Selection criteria include: an election program, public speaking skills, knowledge of legislation and public administration, awareness of current socio-political processes, and level of legal consciousness. Members of the Board of Trustees may participate in the selection process.
19. Based on the interview results, no more than five (5) candidates are selected. A protocol is drawn up and signed by the Chairperson of the Students' Council.
20. The Election Commission and the Board of Trustees take into account candidates' political and social activity, academic achievements, awards, media activity, and social indicators.
21. The Chairperson of the Students' Council is elected on the basis of universal, equal, and direct suffrage by secret ballot. The candidate who receives an absolute majority of votes (50 percent plus one vote) is considered elected. Voters include undergraduate and graduate students, faculty members, and representatives of the University administration. All votes have equal weight. Voting is conducted by ballots, and the secrecy of voting is guaranteed.

VI. Status of the Chairperson of the Council and Early Elections

22. The Chairperson of the Students' Council may not simultaneously engage in employment activities or be a deputy of local or regional authorities.
23. The Chairperson of the Students' Council is issued an identification card and a badge.
24. The Chairperson has the right to:
 - appoint and dismiss coordinators;
 - submit issues for consideration at University meetings;
 - make changes to the structure of the Council;

- exercise a casting vote.
25. The Chairperson is obliged to strictly comply with current legislation and the requirements of this Regulation, participate in meetings and events, promote the role of students, and facilitate the resolution of their issues.
 26. The powers of the Chairperson shall be terminated early in the event of resignation, commission of a gross violation, expulsion from the University, or death.
 27. In the event of early termination of powers, a meeting of the Students' Council shall be held within five (5) working days, and elections shall be organized within thirty (30) days.

VII. Organization of the Council's Activities

28. The main organizational form of activity is plenary meetings, held at least four (4) times a year. Decisions are adopted by a majority vote.
29. The Chairperson: convenes meetings, coordinates the activities of committees and commissions, submits proposals to the University administration, develops international relations, monitors the implementation of decisions, and has the right of veto.
30. The structure of the Council includes the following positions:
 - Chairperson of the Council;
 - First Deputy Chairperson;
 - Deputy Chairperson;
 - Press Secretary;
 - Coordinator for Research Activities;
 - Coordinator for External Relations;
 - Coordinator for Women Students' Affairs;
 - Coordinators for Volunteer Activities;
 - Coordinator for Foreign Languages;
 - Sports Coordinator;
 - Coordinator for Organizational Affairs;
 - Student Dormitory Coordinator;
 - Coordinator of the Proposals and Appeals Center;
 - Coordinator for Intercultural Cooperation and Tourism.

VIII. Final Provisions

31. The Rector of the University may issue letters of recommendation to members of the Students' Council.
32. Reorganization or liquidation of the Students' Council shall be carried out on the basis of a decision of the General Assembly of Students with the written consent of the Board of Trustees.
